1) DEBIT FEE COSTS

RCA provides insurance coverage for third-party liability with respect to reference to persons, property (excluding transported property) and animals. The conveyed person in the Edilfar Rent vehicle is equated with the third party. RCA insurance coverage is included in the fee and has a single and aggregate ceiling of 25 million euros.

a) Theft charge fees (TP) and additional elimination/reduction of debit fee (STP).

All Edilfar Rent rates include TP service. The TP service is not an insurance coverage, but a conventional reduction of the Customer's liability in case of total and/or partial theft or fire within the limits of a maximum amount owed by the Customer to Edilfar Rent upon the event's occurrence. This maximum amount chargeable per event varies according to the group of the car rented as shown in the table below.

b) Damage charge fee (CDW) and additional elimination/reduction of debit fee. (SCDW)

All Edilfar Rent rates include CDW service. The CDW service is not a coverage insurance, but a conventional reduction of the Client's liability for damages found on the car during the rental including road damage, i.e. damage to the vehicle resulting of accidents. The conventional liability reduction occurs within the limits of a maximum chargeable amount per occurrence which varies according to the rented car group and is shown in the table below. The rental contract contains specific prescriptions regarding

the vehicle's use liability; specifically, among these, the observance of proper and diligent use as well as compliance with road traffic regulations; in case of default, even if a limitation of liability clause has been signed by the Customer, the entire damage will be placed on the Customer. Therefore, the limitations of liability will not operate in cases of willful misconduct or gross negligence pursuant to Article 1229 of the Civil Code.

(c) Additional elimination/reduction of theft and damage fee (SCP).

The Super Cover Protection (SCP) surcharge includes SCDW and STP. This supplement is not an insurance coverage and if included at rental time, eliminates the customer's amount due in case of damage, total theft, partial theft, or fire. This liability exclusion is not effective or voids anyways in case of crystal tires and/or wheels damage or theft. The rental agreement contains specific liability requirements for the vehicle's use; particularly, among these there is rule observance of proper and diligent use, as well as compliance with road traffic regulations; even if a limitation of liability clause has been signed by the Customer, in case of default, the entire damage will be placed on the Customer. Therefore, the limitations of liability will not operate in cases of willful misconduct or gross negligence under Article 1229 of the Civil Code.

The additional SCP cost per day is €20.00.

d) Additional elimination/reduction of theft and damage "Full Coverage" fee (SCP Full Coverage)

The Super Cover Protection Full Coverage (SCP Full Coverage) surcharge includes the SCDW, the STP and the SCP. This supplement is not an insurance coverage and if included at rental time, it eliminates the amount owed by the customer in the event of damage, total theft, partial theft, or fire including damage to or theft of windows, tires and/or wheels. The rental agreement contains specific liability requirements for the vehicle's use; particularly, among these there is rule observance of proper and diligent use, as well as compliance with road traffic regulations; even if a limitation of liability

clause has been signed by the Client, in case of non-compliance, the entire damage will be placed on the Customer. Therefore, liability limitation will not operate in cases of willful misconduct or gross negligence under Article 1229 of the Civil Code.

The additional SCP Full Coverage cost per day is € 25.00

2) SERVICES, ACCESSORIES AND ADDITIONS

The economic conditions of services, accessories and additions that can be purchased by the Client are listed below.

- Second driver: € 7.00 per day.
- Urban home delivery and/or pick-up: from € 24.59 each way.
- Delivery and/or pick-up outside office hours (upon specific request): from € 50.00.
- National holiday delivery and/or pickup (upon specific request): from € 50.00.
- FCO APT/LIN delivery/pick up: € 65.00 each way.
- MPX APT delivery/pick up: € 100.00 each way.
- Unlimited KM: € 10.00 per day for Economy cars; € 15.00 per day for other cars and commercial vehicles.
- Anticipated fuel's full: the Client will pay for a full tank of fuel based on the tank capacity of the rented car (from €60 to €100), and must simply return the vehicle with the fuel left in the tank (there are no refunds for unused fuel)

Additions

- Youth Drive (age 18-24): € 10.00 per day.
- Refueling service: € 20.00
- Administrative costs/invoice issuance: € 5.00 per invoice.
- Loss of keys: a tailored fee will be charged to the customer according to the rented car model from € 300.00 to € 700.00.
- License plate's loss/damage: € 300.00.
- Registration card's loss/damage: € 100.00.
- Insurance coupon/certificate's loss/damage: € 30.00.
- One way (trip to leave only upon authorization): € 74.00.
- Cross Border: (upon authorization) € 50 per rental.

Accessories

Upon request and subject to availability:

- Child seats (baby seat): € 40.00 per rental.
- Winter tires: € 15.00 per day (max charge € 105.00).

- Snow chains: € 7.00 per day (max charge € 49.00).
- Navigator: € 12.00 per day (max charge € 84.00).
- Electric vehicle recharge card: € 15 per rental. Recharge fees incurred with the recharge card will vary according to current market rates.

3) PENALTIES

Customers will be charged with additional costs in case of:

- Damaged/missed return of chains Penalty: €100.00.
- Damaged/missed return of baby seat Penalty: €100.00.
- Damaged/missed return of navigator Penalty: € 150.00 for smart cars; € 700.00 for Mercedes cars.
- Damaged/missed return of charging card Penalty (only for electric vehicles): € 100.00.
- Damaged/missed return of charging cables Penalty (only for electric vehicles): € 700.00 per cable.
- Additional unauthorized driving Penalty: € 61.00.
- Indemnity penalty resulting from passive claim: € 300.00.
- Delayed and/or failed to report claim Penalty: € 500.00.
- Unauthorized Border Crossing Penalty: € 150.
- Powering column occupancy without recharge Penalty: if, after a vehicle's full recharge using an Edilfar Rent's card, the Customer does not move out the vehicle within 1 hour from recharge termination, a charge of € 0.20 for each minute of delay will be added to the Customer's expense.

- Mileage Excess: In the event of mileage excess beyond what is foreseen by the purchased rate, a specific charge will be applied to the customer's expense depending on the rented car group: from € 0.30 to € 0.50 + VAT for each additional km. In any case, the Edilfar Rent reserves the right to act for greater damages.
- Fines/warnings re-notification: € 40.00 per fine/communication.
- Non-payment of tolls re-notification: € 15.00 per fine/communication.
- Fines/tickets payment management in case renotification is not possible: € 20.00 per fine/ticket (in addition to the cost of the fine/ticket).
- Extraordinary vehicle cleaning: € 50.00.
- Vehicle sanitization: € 100.00
